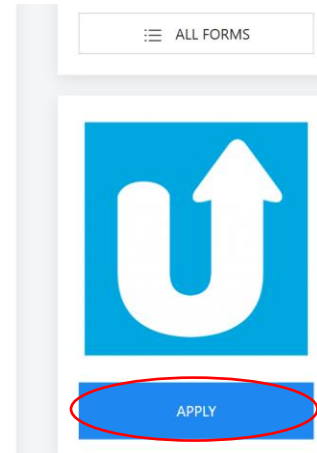

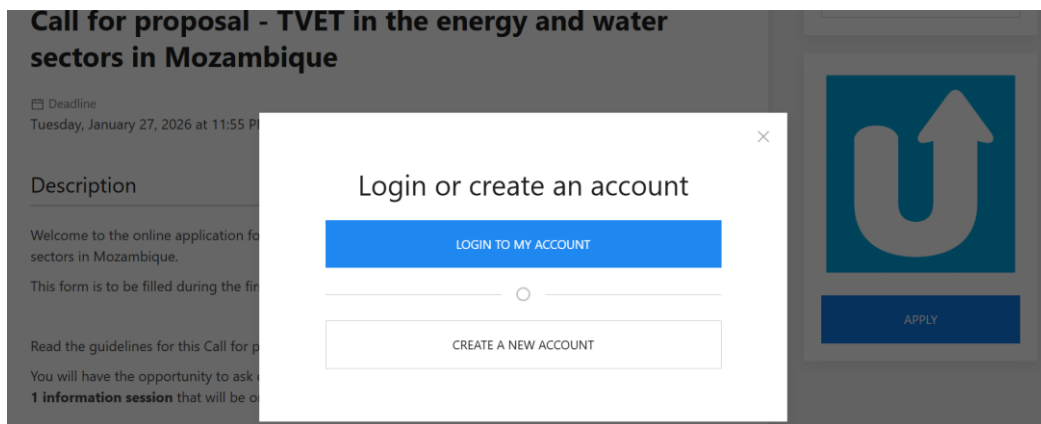
Welcome to the online application form for the Call for Proposals on developing TVET in the energy and water sectors in Mozambique.

This form is to be filled during the first stage of this Call for Proposals.

Read the guidelines for this Call for proposals carefully.



2. When you end up on the landing page, you will read **the description with information about the Call**. You will find integrated links (when hovering over the description), referring you to:
 - a. **Downloadable documents:**
 - i. The guidelines of the Call for proposals (available in English).
 - ii. The guidelines (this document) on how to apply and submit your proposal.
3. Before you can apply and submit your proposal:
 - a. **Registration** is required: you need to register yourself as a user. **Only one user per lead applicant should register.**



- Once registered or signed in, you can click on the button “continue”.

- Once you enter the website, you will see the following screen:
 - You are now in the application form. You will need to **download, fill and upload documents, and answer some questions.**
 - The documents are available in English.
 - You will be able to **navigate in the form**, by clicking on the buttons “back” and “next”.

- On the right-hand side of your screen, you will see an **overview panel of all the questions** (see blue on image above). By clicking on the different topics, you will be able to navigate through all the questions.
- When you must fill in the question, it will show whether it is:
 - An obligatory answer.
 - And/or indicate the upper and lower limit of your answer (e.g. duration, or the budget).
 - Maximum selectable answers.

These questions are related to your concept note. Please note that elements in your concept note (stage 1) can only be changed to a limited extent for your full proposal (stage 2).

Region of implementation

This question refers to the lots of the Call for proposals.

The region of implementation should be in Nampula/Zambézia for the energy sector, and Maputo/Gaza for the water sector. It is possible to target 1 or more regions/lots as an applicant, but you will have to submit multiple proposals (1 per lot/region).

LOT 1: targets the northern region, especially the provinces of Nampula and Zambézia, with a primary focus on the energy sector and the option to include the water sector.

LOT 2: covers the southern region, especially the provinces of Maputo and Gaza, and focuses exclusively on the water sector.
